Refunds in full will be given for bitches in season with appropriate documentation. Remember they are not allowed on or near the trial grounds.

No consumption of alcohol until the tests are complete. Please pick up all trash and debris. If it's raining or muddy, please stay on roads until and unless otherwise directed.

Please watch children and dogs around the horse pasture, as all horses can be unpredictable at times. This is a working ranch, no smoking tolerated anywhere on premises. All participants must respect the land and property and should only drive where directed. Gates should be left as they were found.

No one is allowed access to the house, patio or kennel area except by invitation of the owners. All horses, cattle and livestock are not to be disturbed in any way. Anyone in violation of these guidelines or found to disrespect the land or the wishes of the landowners will be asked to leave immediately.

**Directions:** 13200 N. Hiwassee Road, Jones, OK 73049 Exit I-35, exit number 138D, towards Memorial Road. Exit places you on frontage road. Head South. Turn LEFT/EAST onto Memorial Road, go 7 miles East on Memorial Road. Turn RIGHT onto N Hiwassee Road, it is the first house on the left.
